FREQUENTLY ASKED QUESTIONS

Q.1 Will the contact details of the Living Lab leaders be made available?

No, the contact details of the Living Lab leaders will not be made available on the 5G-LOGINNOV website. Questions concerning the Living Labs may be sent directly to the [Open Call help desk](#).

Q.2 Do interested participants need to address all three Living Labs when applying for the Open Call?

No, interested applicants do not need to address all three Living Labs. However, they should address at least one Living Lab.

Q.3 Are Non-Governmental Organisations (NGO's) or entities other than SME's allowed to apply to the Open Call?

In order to submit an application to the Open Call, eligible applicants should be start-ups in the form of SME's satisfying the requirements described in sections 1,2,3 of the [Open Call Tender Conditions](#).

Q.4 What is a Small and medium-sized enterprise (SME)?

Small and medium-sized enterprises (SMEs) represent 99% of all businesses in the EU. The definition of a SME is important for access to finance and EU support programmes targeted specifically at these enterprises. The main factors determining whether an enterprise is an SME are: (1) **staff headcount** and (2) **either turnover or balance sheet total**. Small and medium-sized enterprises (SMEs) are defined in the [EU Recommendation 2003/361](#). For more information on the definition of a SME, please have a look at the Comision document '[User guide to the SME Definition](#)'.

Q.5 Is it possible for a company to apply to the Open Call if it is already obtaining EU funding for the same type of work in another EU project?

It is the responsibility of the applying companies to make sure that they fulfill the eligibility criteria set out in the [Open Call Tender Conditions](#). In the case of already receiving EU funding for other projects, funding for the Open Call can only be obtained if it falls under the category 'additional work'.
